- 1. Candidates take the course integration of Technology in the Classroom (EDUC 301). This course includes preparing blogs, interactive modules for the teaching-learning process, videos and CD's of micro-teaching, a radio program using an open source software on an education topic, power point presentations, hiperlinks for resources and activities, managing audiovisual equipments, sending email using the ECAMS System, using the digital camera, among other activities.
- 2. Professional courses require students to use word processors, spread sheets, make power point presentations, send e-mails using ECAMS system, and use audiovisual aids for class presentations.
- 3. Education classrooms have computers, projectors, electronic whiteboards, and other audio-visual resources.
- 4. Candidates are required in field experience to provide evidence of impacting students learning using technology.

- 1. The Teacher Education Program require candidates to take a course on teaching the exceptional child. since August 2015 includes technological assistance.
- 2. The University established a Language Institute for helping students with limited English proficiency.
- 3. The University received the TRIO grant with emphasis on English as a Second Language (ESL). This program will greatly benefit all UAA students and programs by providing individualized tutoring, reinforcing English skills, academic counseling, financial counseling, and visits to other institutions. These services are free for students.

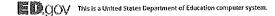
