To verify that you provided correct information, we will compare your FAFSA with the information on this worksheet and with any other required documents. If there are differences, your FAFSA information may need to be corrected. You and a parent whose information was reported on the FAFSA, must complete and sign this worksheet, attach any required documents, and submit the form and other required documents to your school.
