# FROM THE DIRECTOR'S DESK

Since October 2024, we have been blessed with the approval of our PPOHA proposal, Promoting Diversity and Inclusion in Graduate Opportunities through Distance Learning, supported by a \$3 million budget originally scheduled for implementation from 2024 to 2029. During this first year of execution, our institution has successfully achieved the proposed objectives, and we remain profoundly grateful to God for this opportunity and for the support received from our university community.

Regrettably, in this newsletter corresponding to the July–September 2025 quarter, we must announce that we have received an official Notice of Discontinuation of the Title V grant. This decision, communicated on September 11, 2025, by the U.S. Department of Education under the Developing Hispanic-Serving Institutions (DHSI) program for Title V, Parts A and B, applies to all federally subsidized proposals under this initiative. Consequently, our project will formally conclude in March 2026, following a six-month closing phase.

Despite this unexpected development, we wish to highlight the significant progress and achievements accomplished through the PPOHA project. Over the past year, we have strengthened graduate opportunities and enhanced the institution's capacity for distance learning, aligning with our mission and vision. Looking forward, as the Project director, I will dedicate the closing phase to implementing a structured plan of action, which includes documenting outcomes, finalizing reports, and ensuring the sustainability of selected initiatives beyond the grant's life.

We express our deepest gratitude to God for allowing us to serve through this project.

# polight: PPOHA PROJECT ACHIEVEMENTS, NON-COST EXTENSION ACTION PLAN, AND INSTITUTIONAL FUTURE DIRECTIONS

Since its approval in October 2024, the PPOHA project *Promoting Diversity and Inclusion in Graduate Opportunities through Distance Learning* has played a transformative role in expanding graduate education and strengthening institutional capacity at Universidad Adventista de las Antillas. With a \$3 million award originally spanning 2024–2029, the project has successfully advanced key objectives during its first year, laying a strong foundation for the future.

## **Achievements to Date**

The accomplishments of the PPOHA project reflect a broad impact across academic programs, student services, faculty development, and infrastructure:

- Graduate Academic Programs: Approval of the MSN in Critical Care and Elderly Care (July 2025), the MBA in Human Resources (April 2025), and the Graduate Certificate in Educational Technology (June 2025), all launching in November 2025. The Graduate Certificate in Skin & Wound Care was submitted to the Puerto Rico Board of Postsecondary Institutions in September 2025.
- Graduate Student Services: Completion of the Graduate Student Needs Assessment (Spring 2025), leading to the development of a Comprehensive Student Support Plan.
- Faculty Development: A comprehensive needs assessment led to the launch of the Faculty Professional Development Initiative. Faculty completed training in AI-enhanced learning, prompt engineering, and online teaching, with an overall 70% completion rate by September 2025.
- Graduate Center Modernization: Phase I modernization completed, including technological infrastructure upgrades, relocation of the Graduate Center to the library (CREG), and procurement of key academic resources such as Cengage, ClinicalKey, Zoom, and ProQuest databases.

These accomplishments, achieved with dedication and collaboration, highlight the institution's commitment to graduate excellence and student success.

## **Non-Cost Extension Action Plan**

Following the federal Notice of Discontinuation of Title V grants, the project was granted a six-month non-cost extension through March 31, 2026. This extension will ensure the orderly completion of activities and full accountability for resources. Key priorities include:

- Curriculum Development: Finalizing three graduate programs—Graduate Certificates in ABA Clinical, ABA Educational, and Elderly Care—aligned with accreditation standards and delivered through Moodle.
- Graduate Center Modernization: Completing physical upgrades, addressing technological infrastructure needs, and equipping the Skin and Wound Care Simulation Lab.
- Student Support and Scholarships: Awarding 20 scholarships for the first cohort of students enrolled in the newly approved graduate programs beginning November 2025.
- Faculty Development: Increase overall completion rate from 70 % to 75%.
- SIS/CRM Implementation: Installing the Orbund Einstein platform to centralize student services, improve data management, and strengthen retention and success strategies.
- Accountability and Evaluation: Ensuring compliance through external evaluation, inventory finalization, and submission of all financial, performance, and programmatic reports.

# **Future Institutional Directions**

Although the discontinuation of federal funding represents a challenge, the institution remains steadfast in its mission to prepare competent, values-driven graduate professionals.




# Phase I of Technological Infrastructure modernization completed. Graduate Center relocating to CREG (library) -> modernization with advanced technologies, and support areas.
